

## EXPLANATION OF THE AD VALOREM TAX & NON-AD VALOREM ASSESSMENT NOTICE

1. **AMOUNT DUE** – All taxes are due November 1 and become delinquent April 1.  
NOTE: A discount is given for early payment. You save the most by paying in November. The DISCOUNTS HAVE BEEN COMPUTED AND DEDUCTED FOR YOU – PAY ONLY ONCE.
2. **PARCEL ID #** - Quick reference number. PLEASE use this number in all communications.
3. **MILLAGE CODE** – For identifying the specific Districts.
4. **ESCROW CODE** – Identifies special billing or lending agency which may be paying taxes. If you receive a DO NOT PAY notice and do not have an escrow account, please submit payment in US Funds drawn on a US Bank.
5. **IMPORTANT MESSAGE AREA** – Used to direct your attention to important information.
6. **LEGAL DESCRIPTION** – Property as described on your deed. NOTE: The Official Record Book and Page where your ownership document is recorded with the Clerk of Courts' Office is indicated by OR..PG..
7. **OWNER OF RECORD** – Owners name and mailing address as of certification date.

8. **VALUE** – Assessed, Market and Exemptions determined by the PROPERTY APPRAISER.  
Taxable – Value on which the property is taxed. (239) 252-8141.
9. **TAXING AUTHORITY TYPE** – The type of authorities responsible for establishing Ad Valorem millage rates
10. **MILLAGE RATE** – Determined by the taxing authorities.
11. **MILLAGE TOTAL** – Total millage applied to taxable value.
12. **AD VALOREM TAXES** – Millage rate times taxable value.
13. **NON-AD VALOREM ASSESSMENTS** – Determined by other Independent Special Districts not included under #12.
14. **COMBINED TOTAL** – Total Ad Valorem Taxes and Non-Ad Valorem Assessments
